Surcharges and demurrage costs:

- Units are permitted to remain standing 24 hours free of charge in the Port of Oslo/Alnabru, subsequently the following charges will apply:

Stackable units <= 25' (= <7.82 m), 1 TEU	NOK 229.00
Stackable units > 25' (>7.82 m), 2 TEU	NOK 458.00

Trailers/swap bodies > 25', (>7.82 m) 2 TEU	NOK 915.00

- Units are permitted to remain standing 72 hours free of charge in the Port of Trelleborg (after 72 hours €24.00 will be charged per day/unit)
- Units are permitted to remain standing 72 hours free of charge in the Port of Rostock (after 72 hours €10.00 will be charged per day/unit)
- Units are permitted to remain standing 24 hours free of charge at the Verona Q.E. Terminal, subsequently the following charges will apply:

- Trains with loading time between 00:00 and 23:59 - Cancellation is free of charge until 18:00 the day before.
- For cancellations between 18:00 the day before and 10:00 on departure day, a cancellation charge of 30% on agreed shipping order price will be invoiced. After above mentioned deadlines €400.00 will be invoiced.
- This also applies if fixed slots for the train are agreed and the specified deadline for using them is not held.
